Considering the situation of the convicted ADAMESCU GRIGORE DAN, PIN code 1480920978329 born on 20.09.1948 in Romania, Valcea county, Ramnicu-Valcea city, son of GRIGORE/EUGENIA we found the following:

Runs the convictions:

Mandate 28/2016, 17/2015 number of the sentence, issued by Bucharest Court of Appeal Sec. II P for Author - Law to prevent corruption (Law 78/2000), for 4 years and 4 months.

Special mentions (reductions, disruptions of punishment etc.):

0 days in prison during the interruption of penalty

Description of the action: In December 2013 he offered the S.I. judges, through the witness O.D. and through the liquidator B.M.A., the amount of 15.000 euro and R.E. the amount of 5000 euro within the Bucharest Court VII Civil section for favorable settlement of certain files (Act retained in the contents of the Preventive arrest warrant No. 15 / 06.06.2014 of the Bucharest Court of Appeal from the joined file, as from the existent record to the current file (Sp 17/02.02.2015 of CAB II and that of MEPI 28/2016) the description of the offenses committed are not clear.

The enforcement of penalty started on 27.05.2016 and will expire on 09/09/2016, because the arrest of 383 days is subtracted and 0 days in the escape, disease causing, interruption of penalty enforcement, cumulative etc.
